

## Patrons and Friends – their vital role

When our concerts began in 1988, we wanted to explore a wide range of chamber music and to hear it played by the best talent of the day. We hoped that others would share our aims. Our continuation, thirty years and two hundred concerts later, shows that they did and still do. Even on this scale running such an enterprise is expensive. Ticket income alone cannot fund all the expenses and overheads involved, particularly if we present works with more than four performers, or music which is unfamiliar and challenging and needs extra rehearsal. So those who contribute something extra play a vital part in keeping music alive, as well as making tickets for our concerts affordable for those of more limited resources. Happily, a small but enthusiastic band has from the start been keen to support our activities with regular subscriptions. In 2017 *Concerts at Cratfield CIO* took over from the former charitably trust, Blyth Valley Chamber Music. The CIO has identical aims, is registered with the Charity Commission and its founding Trustees have a long history of involvement with our concerts. Those annual subscribers who used to be called *Members* have been renamed *Friends*. Our reliance on those keen to support us financially, beyond buying tickets for our concerts, remains unchanged. *Patrons* have four weeks' booking priority each season, followed by *Friends* who have two weeks. We also have occasional special events for *Patrons* and *Friends* and a lively AGM when any aspect of our concerts can be raised, followed by a buffet lunch and a chance to carry on the discussions. Do join us if you can. *Friends* pay £20 a year (one individual) or £30 (two people at the same address). *Patrons* pay a minimum of £96 a year, or £8 monthly (for up to two people at the same address). All subscriptions run for a calendar year.

## Reclaiming tax on your donations

Since 6 April 2000, all donations to charity made by a UK taxpayer can be treated as Gift Aid donations, if the donor makes a Gift Aid Declaration to the charity. With this Declaration, we can currently reclaim an extra 25p for every £1 you donate to *Concerts at Cratfield CIO*. Your annual subscription as you are a Member qualifies as a donation, but we can reclaim too on any one-off donations which you make, at the prevailing rate.
